# **2013 Annual Report**

As a non-profit agency primarily funded through the state government, we're continually asking ourselves, "Are we effective?" "Are we increasing the availability and accessibility of child care programs, promoting the development of quality child care services and advocating for child care issues as our mission implies?" "Are we wisely using the state's resources?"

One of the ways in which we measure our effectiveness is through outcomes. "Did we meet the objectives and reach the people we thought we would?" In 2013, we believe we made a difference

in the lives of children and families in Central WI. For example,

in 2013, over 1,000 families were assisted in helping to find quality child care arrangements for their young children. Decades of research demonstrate that high quality, developmentally appropriate early childhood programs have short and long-term positive effects on children's cognitive and social development.

The Scholarship Aid program funded by St. Joseph's Hospital Ministry Fund, United Way of Inner WI, Marshfield United Way and Community Grants Fund through Incourage Community Foundation assisted with payments for 34 families with 55 children in 2013. For a majority of families, child care is not a luxury but a necessity; and child care can account for a larger percentage of a families' budget than their food, monthly utilities or even a car payment.

We also made a difference to area child care programs. Training is one tool that Childcaring uses to retain existing child care programs and improve program quality. Last year, over 1,500 training participants throughout the 10 county service area were trained in topics such as child portfolios; shaken baby syndrome

# Is there a cost to the program for participating in YoungStar?

There is no cost for child care programs to participate in YoungStar In fact, YoungStar helps programs by providing training, technical assistance, and small, targeted micro-grants to help them get the things they need to improve and help kids learn more effectively.

However, quality improvement does cost money, such as when a program chooses to invest in higher education for its staff or purchase additional learning materials for children. Providers can contact Wisconsin Early Childhood Association (WECA) to request an application for T.E.A.C.H. Early Childhood® Wisconsin Scholarship Program: http://wisconsinearlychildhood.org/programs/teach/(Or contact a WECA Professional Development Counselor at 1.800.783.9322, selecting Option 3 when prompted.)

Programs may make the decision to target additional resources to increase and maintain the quality of their programming.

prevention; challenging behaviors; strengthening families along with child abuse and sexual abuse prevention.

Participation within YoungStar, Wisconsin's quality rating and improvement system continues to increase. On-site consultation is one of the most effective ways to change practice. A child's caregiver has a great impact on the quality of his or her early care and learning experiences. In 2013, 190 child care providers in the CCR&RCW service area and 164 child care providers in the CCC service area participated in YoungStar.

Childcaring impacts communities by helping to build the supply of child care and create awareness about the importance of high quality early learning environments for ALL children. ### The Brain Adapts to Any Environment

Because experiences have a major influence on the way a brain develops, the brain wires to adapt to any environment. A young child's brain will adapt to a negative environment just as easily as it will adapt to a positive environment.

Prolonged, severe, or unpredictable stress, including abuse and neglect, during a child's early years can result in lasting negative impacts on the child's physical, cognitive, emotional, and social growth.

Babies who do not get consistent responses to their cries, or those whose cries are met with hostility or indifference, develop brain connections to prepare them to cope in that environment. As a result their ability to learn and respond to nurturing and

kindness may be impaired.

It is simple to provide these positive experiences in everyday life to stimulate the healthy brain growth of young children.



### **Activity Idea:**

#### **Sharing Feelings**

Match your reactions to the emotions

I am expressing. For example: Say, "Oh you are sad," and comfort me. Or "You are so happy!" and clap hands with me.

Brain Insight: When you tune into my emotions and respond to what I need, it helps me make the very important connections I need in the emotional areas.

# 2013 Wisconsin Act 20 Changes For Certified Operators

On June 30, 2013, Governor Walker signed Wisconsin Act 20 into law, which is the executive budget for the 2013 legislature. The law took effect on July 2, 2013 and included, in part, a change to the caregiver law that requires a one-time fingerprint-based criminal background check for certified operators, adult household members and other adult caregivers of programs that are receiving or eligible to receive payments from Wisconsin Shares. This law does not require fingerprinting minor caregiver employees or household members 12 to 17 years of age. If, in the past, an individual had a fingerprint –based background check conducted by the certification agency (due to residing out of state), they are not required to submit fingerprints again to meet this new provision.



### **One-Time Fingerprint-based Criminal Background Check Requirement**

- Operators and Adult Household Members Under the provisions of the new law, all certified operators and adult household members of a certified child care program currently receiving or eligible to receive Wisconsin Shares payments will be required to submit fingerprints to the certification agency for the purpose of a national and state criminal background check.
- Caregivers (Employees/Volunteers) Certified operators receiving or eligible to receive Wisconsin Shares payments will be responsible for submitting fingerprints for all adult caregiver employees/volunteers. If the certified operator also holds a license under DCF 250, DCF 251 or DCF 252 and conducts name-based background checks on his/her employees/volunteers then the operator may conduct the one-time fingerprint-based background check.

### Implementation of the Provisions of the New Law

Certification agencies will begin implementing the one-time fingerprint-based background check provision June 30, 2014. Beginning **June 30, 2014**, anytime an individual or entity submits an application for certification and indicates the program wishes to be eligible to receive Wisconsin Shares payments, a one-time fingerprint check will be conducted on the applicant, any adults who reside in the center, and on adult caregivers. Certification agencies will provide new applicants and existing certified operators with detailed instructions on the collection and submission of fingerprints.
