All Wisconsin child care providers who serve children from birth through their school years can participate in YoungStar, as long as they're in good standing with state regulations. In fact, providers that receive a Wisconsin Shares Child Care Subsidy must participate. When

they do, they gain access to training opportunities, technical assistance, even micro-grants to fund books and learning materials. In that way, YoungStar doesn't just rate the quality of Wisconsin's child care. It improves it.

What are some incentives for child care providers to participate in YoungStar? Of course, the most important incentive for participation in YoungStar is the opportunity to improve program quality and thus improve the outcomes for the children enrolled in your program.

Other benefits available to programs participating in YoungStar are:

- 🚖 On-site training and technical assistance, upon request
- Local training opportunities
- Professional development counseling and supports for credit- and noncredit-based growth opportunities
- Micro-grants \$200, \$250, \$500, or \$1,000 (amount varies according to the providers regulation type) to support the goals outlined in programs' Quality Improvement Plans

YoungStar Updates

- 2017/2018 YoungStar criteria will be finalized on November 1. DRAFT criteria is currently available on the YS website for review. http://dcf.wisconsin.gov/youngstar
- ★ Starting July 1, 2016, if you are going through the formal rating process, your Technical Consultant (TC) will score the YoungStar Evaluation Criteria for your program. SFTA's Environment Rating Scale (ERS) Observers will only complete the required Environment Rating Scales for each rating. Your TC and the ERS Observer will collaborate during the final consultation to give you thorough and meaningful feedback to draw upon your strengths and support you in your future quality improvement efforts.
- Beginning in 2017, programs participating in YoungStar will only need to be rated every two years. This will give programs more time to improve their quality between ratings. All currently participating program sites were divided between even year and odd year rating groups in July, 2016. Programs were divided through a computer generated system that took a variety of factors into consideration. Even year and odd year rating assignments were mailed to programs in August. Note that programs are not able to change which rating group they are assigned to. Not sure if your program was assigned to the even or odd year rating? Once Upon a Book Drive Collects Record-Breaking Number of Books for Wisconsin Children in Need

Childcaring, in partnership with Supporting Families Together Association (SFTA) and their other participating member Child Care Resource & Referral (CCR&R) agencies and Family Resource Centers (FRCs), finished off the annual Once Upon a Book Drive this year with 9,868 books collected statewide—more than 4,200 over the highest number of books collected through the drive in any prior year. Childcaring collected 2,024 of these books to distribute locally.

Studies have shown that positive early literacy experiences are crucial to language, reading and writing development, skills that can play a significant role in the development of a child into adulthood. A young child accessing quality literacy materials now is more likely to be successful later on in areas of school readiness, employment and self-sufficiency. This is why programs like Once Upon a Book Drive that increase early access to literacy materials are so crucial.

Books collected through Once Upon a Book Drive will be distributed to early education programs and families in need throughout Wisconsin by CCR&Rs, FRCs and SFTA. Childcaring will distribute books through our services in Adams, Clark, Langlade, Lincoln, Marathon, Marquette, Portage, Taylor, Waushara, and Wood counties. Outside organizations may apply to receive books to distribute through their services if they are a non-profit and meet the additional qualifications:http://supportingfamiliestogether.org/applyforbooks/.

A special thank you to the organizations who served as local drop off sites for the book drive: Portage County Public Library, Stevens Point; Lester Public Library of Vesper; and T.B. Scott Free Library, Merrill. We hope to continue this partnership in the years to come.

"Better late than early," says Occupational Therapist Marianne Gibbs, EdD, OTR referring to having children use pencils and other writing utensils. She advocates for building strength and agility with fun and appropriate motor activities. She suggests waiting until the child is 4 or 5 to expect a child to hold a pencil. Here are some activities you can try to increase the children's ability to later hold a pencil – all seem like things we already do but do them more! Need more ideas? Go to Pinterest and search "pincer grasp."

Put objects, snacks, counters, toys in zipper type sandwich and storage bags.

Use tongs of varying sizes to pick up objects. Use finger puppets. Have children use stickers.

WREA will be available during regular business hours, 8a-4p, October 3, 2016 – October 7, 2016 to assist you in making your first payment to your child care provider. Walk-in's only, no appointments necessary. WREA local county ES agencies include: Pepin, Buffalo, Trempealeau, Clark, Jackson, Monroe, Vernon and La Crosse.



There will also be assistance after business hours at select local County ES offices October 4, 2016, October 6, 2016 and Saturday morning October 8, 2016.
