DCF Announces Community Innovation Grant Recipients

Childcaring Receives \$150,000 to Expand GSG Program to Three Rural Counties

The Department of Children and Families (DCF) has awarded roughly \$850,000 in Community Innovation Grants (CIG) to eight organizations across the state to expand available early care and education opportunities for young children ages birth to five and their families.

The grants, which are funded from the state's Preschool Development Grant – Birth to 5 (PDG B-5) award, ranged in size from \$50,000 to \$150,000 and support innovative programs and partnerships that address areas of equity, access, affordability, quality, and workforce as highlighted in the state's Birth to 5 Statewide Strategic Plan. The grants are also being utilized to develop stronger public-private partnerships that will serve as models for future community investments in other parts of the state.

"Having access to high-quality early care and education opportunities is critical for our communities to thrive," said DCF Secretary Emilie Amundson. "These grants are a deliberate step to begin engaging community businesses and organizations to connect with their early care and education system to learn about their role in supporting a healthy local economy."

"Childcaring, Inc. is extremely pleased to be one of the eight organizations across the state awarded the Community Innovation Grants (CIG) from the Department of Children and Families (DCF). Childcaring is assisting families in gaining access to high-quality, affordable early care and education by expanding its Good Start Grants (GSG) program to three new counties (Langlade, Lincoln, Taylor)," said Childcaring Assistant Director Micki Krueger.

The GSG program provides personalized assistance to families by helping them find care that best meets their needs, as well as funding to cover the costs. Additionally, Childcaring will be providing local programs with stipends to help achieve or maintain a YoungStar rating. "To date, in Marathon and Portage County GSG has helped 279 families (a total of 427 children). Expanding GSG to more counties is a great financial resource for families," said Childcaring GSG Coordinator Rachele Johnson. Families struggling to pay for child care costs in Langlade, Lincoln or Taylor County are encouraged to contact Childcaring or reach out to their current child care program for more information.

Through local investment activities like the CIGs, the department is working to connect the dots across state and local programs to better serve all Wisconsin children and families. New opportunities for funding will be available in the coming year and beyond as the state continues its work to improve Wisconsin's early childhood system. DCF encourages anyone who could be a stakeholder to apply.

YOUNGSTAR CORNER

Ask Your YoungStar Technical Consultant About Practice Based Coaching (PBC)

Practice-Based Coaching (PBC) is an individualized form of professional development available to programs participating in YoungStar. During the PBC process, a YoungStar Technical Consultant (TC) works with a provider to identify specific teaching practices they would like to improve. The TC will assist the provider in creating an action plan to achieve their goals, while providing support, observing progress and sharing feedback.

For example, a provider may identify literacy as an area that they are interested in improving upon. The program's TC will provide a literacy specific needs assessment, which will help the provider and TC determine a specific teaching practice to work on, such as reading to children more often. Using the PBC model, your TC will work with you to write a specific goal and action steps to help you achieve it. In addition, your TC will provide resources and support, observe the teaching practice in action, and offer feedback.

Child care providers who used PBC said,

"PBC helped me make changes (to teaching practices) that I have been thinking about for a while but haven't done anything to accomplish until now."

"PBC is a great way to help staff create positive classroom environments."

"Don't hesitate to take advantage of a PBC cycle. Going through a PBC cycle provided me with that extra "nudge" to implement some practices that I kept delaying. I was provided step by step guidance, direction, and accountability to make completion simple and achievable. It is worth the effort to complete a PBC cycle. Take advantage of this resource!"

Update Your Business Information Form ASAP

Childcaring continues to work hard to collect data through the Business Information Form (BIF) to support the child care industry. Our data collection is used frequently to bring awareness to the needs of the child care profession and to support the work you do!

A new systems interface is currently in development between the Wisconsin Department of Children and Families (DCF) child care systems and the Wisconsin Child Care Resource & Referral (CCR&R) system. Child care regulatory and YoungStar rating information will now flow between DCF and Childcaring as well as information collected through the Business Information Form (BIF). Examples include open vacancies, enrollments, waitlists, program philosophy, and schedules. Eventually, this information will be displayed in the DCF Provider Portal and a subset of it will be included in the Child Care Finder. DCF and CCR&Rs will use this information to better serve the children, families and child care providers in Wisconsin.

Please complete and return the BIF ASAP to ensure that your information is current and accurate in the system.

It is a privilege that the families entrust us with their children and we are so fortunate to get to play a role in their children's lives during those vital first five years. I love that our center has a large sense of community and the people I work with are like my family. We all have a desire to positively impact the lives of the children we work with. I live for being able to teach a child something new and watching the 'twinkle' in their eyes when they understand a skill and seeing how proud they are." - Kari S.

"We can be that special person for them when they are away from their grown-ups, we share many smiles and fun times with them and comfort them when they need it. Teaching them to take turns or be kind is the start of continuing those traits later in life." - Nina M

"I enjoy teaching them all the skills and building the foundation for the rest of their educational journey." - Tori B.

What are some fun and innovative practices that you implement at your program?

We do a lot of outdoor art and sensory experiences. We paint with water colors on big sheets of paper outside. The children have made art using nature as their tools. They have painted with bikes by riding over the paint on the paper. We color with markers and chalk and crayons both collaboratively and individually outside. The children play with shaving cream and blocks or other toys in the outdoor sensory table. They play with water and dirt and make mud for their trucks or dinosaurs. The children will use soapy water and sponges and do car washes, bike washes, or give their babies or dinosaurs baths. The children will go on scavenger hunts and nature hikes around campus and in Schmeekle. We love exploring Schmeekle Reserve, they enjoy searching for different kinds of bugs, building structures with fallen branches, and searching for interesting rocks. They are so imaginative and create all different scenarios using the items and tools that they find in nature. They have even built little structures with branches that they can sit underneath to eat their snack.

The children in the infant room are with the same teacher for 2 years creating a stable family environment for the children to feel safe, secure and nurtured. Children can get overwhelmed easily so we provide a soothing environment, we make sure the lights are not too bright, the colors in the room are more natural. Our walls are not full of clutter. Our children all have their own responsibilities in our classroom to help build a sense of ownership and pride in our school classrooms.

This year we read the book titled Me on the Map by Joan Sweeney. This triggered our curiosity into learning about the world around us by conducting an investigation into the community we live in and broadening our exploration to a world-wide scale. We studied life in the Arctic, Africa and Asia. We started with our homes where parents provided us a picture of their home and the children drew a replica of it and a self-portrait that we posed for, in our classroom. We mapped out the university and hiked daily to a different location such as the police station, practice fields, and all the different buildings on campus.

UCLCC has been recognized among the 2021 U.S. Department of Education Green Ribbon Schools award honorees. Nominated by the Wisconsin Department of Public Instruction, UCLCC is one of three early learning centers across the country to earn this recognition. Our center was chosen for innovative efforts to reduce environmental impact and utility costs, improve health and wellness of schools, students and staff; and provide effective environmental and sustainability education.

"The University Child Learning and Care Center is honored to receive recognition for our work in environmental education and sustainability practices," said Alicia Utke-Becher, a preschool teacher at the center. "Our mission to develop better practices has been a long-term effort. Through continual education of teachers, a relationship with Wisconsin's Green and Healthy Schools and our university and community partnerships, we have developed a school culture of environmental awareness of which we can all be proud."

Among the UCLCC's many sustainability practices:

- Use of a natural playscape playground using environmentally friendly and recycled materials, an eco-friendly artificial turf that eliminates watering and adding a tree for cleaner air and shade
- Using the outdoor areas for play-based approach for environmental STEM exploration
- Use of natural light, energy efficient light bulbs and designating students who turn off lights when not in use
- Off-site visits to Schmeekle Reserve, local farms, gardens to teach environmental citizenship
- Teaching children composting of waste through the center's two vermicomposting units (using worms) and using it in the center's garden as well as compost from local organic farms
- Using fresh produce from the center's garden as healthy snacks
- Earning the highest designation as a Green and Healthy School Wisconsin

Start Up Grants are Available! Since 2017, over \$20,000 in Start-Up Grants has been allocated to child care providers in our service delivery area. Eligible providers have used the funding to purchase equipment and materials, and classes required to obtain regulation (ie: fencing, safety gates, developmentally appropriate materials for a variety of age groups, smoke detectors, fire extinguishers, etc.). Contact Childcaring to learn more about start-up grant eligibility. If you became regulated within the past three months you may still be eligible to apply.

DCF Child Care Provider Update

Reminder: Updated Guidance on Mask Wearing & Social Distancing (6-3-21)

As vaccination eligibility expands, public health guidance around mask wearing and social distancing has been relaxed for the general public who are vaccinated. However, the next several months will be a transitional period where younger children (ages 11 and under) are not yet approved for vaccination, so prevention strategies remain important to mitigate the spread of COVID-19 and protect the health of younger children.

To that end, we wanted to clarify the current guidance for programs serving younger children, outline the expected timeline and next steps, and update you all on our approach during this transitional period.

Guidance for programs serving younger children: The vaccine is not yet approved for children 11 and under, so the CDC and state health guidance **strongly recommends children and adults (regardless of vaccination status) in schools, child care programs and summer camps continue mask wearing and social distancing indoors until younger age groups are eligible for vaccination this summer and later this year.**

Expected timeline for expanded vaccine eligibility: Clinical trials are underway for younger children, and we are optimistic all school age children (ages 5-11) may be eligible for vaccination later this summer with infants and toddler likely following in the fall. **As vaccination is approved for younger children, we expect the guidance around mask wearing and social distancing will be relaxed for those age groups.**

Regulatory approach during the transition period: DCF will focus on providing technical assistance to programs and supporting providers during this transition. **To that end, there will be no enforcement actions around mask wearing moving forward.**

Start with your goal(s), then go searching for your activities:

WMELS C.EL.1 Develops ability to detect, manipulate, or analyze the auditory parts of spoken language.

Certainly the more nursery rhyme activities you can do the better! When you are working with nursery rhymes be sure to emphasize the rhyming words since the purpose is for the children to hear the parts of word and manipulate them.

Have a classroom puppet and have the children create words that rhyme with the puppet's name. Have the puppet laugh and enjoy the attention. If they get really good at it you could then use the puppet's middle name and last name to do the same thing with new ending sounds. Use the puppet to help with other rhyming activities.



To become good listeners with spoken language having children tune into the sounds around them helps to train their ears. While outside or inside point out the sounds you can hear and see if they child can identify them. For children who are non-verbal be prepared with a set of pictures of possible sources of sounds you might hear so they can point to the picture.


