Quality early care and education promotes: healthy brain development in children, support for working families, economic impact, school readiness, lifelong skills, and more. However, a steady decline in child care providers is making it challenging for children to get the care they need.



Child care providers are needed. Over the past 10 years, the central Wisconsin area has lost over 400 regulated child care providers. “We have heard from parents that they may lose their job or may need to quit if they don’t find child care. Parents are sometimes put on waiting lists that can be out a year or longer,” Childcaring Executive Director Kelly Borchardt said.

Increasing the number of child care providers in central WI is important work. If you or someone you know is interested in providing child care, contact Childcaring. Start up grants are available. Eligible providers have used start up grant funding to purchase equipment, materials, and classes required to obtain regulation. To learn more about providing child care register for an upcoming:

WI Dept of Children and Families (DCF) has issued an intent to award a new contractor for YoungStar (YS) services. The current contract administrator, Supporting Families Together Association (SFTA), submitted a Letter of Protest on May 3, 2022. All YS services will continue as normal, for now. **The Child Care Resource & Referral (CCR&R) agencies across the state, including Childcaring, remain available to offer child care and family support related services.** We are very proud of the exceptional YoungStar services we provide in collaboration with SFTA. We value the relationships Childcaring has with providers and the successful outcomes that continue to increase the quality of child care for Wisconsin's children.

Even before the COVID pandemic, trauma was widely prevalent in our society. The collective trauma we are all experiencing now as the result of this pandemic has only exacerbated the issue. Moreover, trauma has negatively affected organizations taxing already stressed systems of care and practitioner wellness. Trauma-informed care is an intervention and organizational approach that focuses on how trauma may affect an individual's life and their response to services. This presentation will examine the adverse childhood experiences (ACEs) study and explore the many faces of trauma and its prevalence in society. We will discuss how the application of the six values of trauma-informed care drive connection and can be applied in multiple service settings. Never has this topic been more relevant and needed to serve each other and those depending on us for help.

What does staff enjoy most about working in early care and education?

What was your favorite part about participating in the Virtual Huddles for Child Care Providers?

The best part of participating in Childcare Huddles is getting together monthly to talk with colleagues (child care providers, Directors and YoungStar Consultants) to discuss ideas and to get different perspectives on the multitude of topics offered each time. It also helps me to remember that we are all here for the same reason, the children. It’s wonderful to be able to bounce ideas off others who have maybe experienced similar situations at one time or another. So many providers bring a plethora of information to the table and are willing to share this wealth of information when we listen in the huddles. Huddles have become a learning tool in itself for me as I am always eager to learn and apply new information to my job.

How has YoungStar helped your program grow?

Our Center has recently moved from a three star to a four star on the rating scale with YoungStar which is extremely exciting for us. Our YoungStar consultant is fabulous. She gave continued support, feedback and awesome ideas and suggestions on how to improve as a Center and how to excel as teachers. She provided suggestions regarding lesson planning, room set up and configuration of centers, provided developmentally appropriate toys in those centers, and made sure the classrooms met YoungStar requirements for developmentally appropriate environments which was extremely helpful for our improved rating. We couldn’t have done it without her expertise.

Director Cohort –

Supporting Teachers to Create Healthy Environments and Longevity

Directors continue to seek the answer to a question that seeps into all conversations and across the work force. How do directors support teachers to create healthy environments and longevity? In an attempt to be proactive vs reactive, directors are searching for systems to have in place to support teachers and the needs in the classroom. The directors have a good understanding of turnover and the deficit it leaves the program in. What is puzzling is how to stop it? Or at least minimize it? This makes for many more questions than answers.

The directors viewed videos from the book, “Coaching with Powerful Interactions.” The directors were able to review and discuss observation, goal setting, mentoring, and coaching. The videos showed one-on-one conversations between teacher and director. These examples showed strength-based reflective practices which foster trust and support.

The Director Cohort continued their quest for answers about support and had the privilege of a guest speaker from DCF, Jason Rahn. The presentation titled, “Supporting Those Who Support Others,” touched on three topics; Supporting Your Program (setting expectations through program policies), Supporting Teachers (seeing things differently), and Supporting Children (who have behaviors that are challenging to adults). The information-packed session explained the importance of an adult’s reaction to a child’s behavior and how to support adults and children. To start, Jason posed questions about policy and its impact and importance on procedure in a program. He states, “The best way to support the teachers, staff, and families in your program is to develop expectations and procedures for how your program will respond to challenging behaviors”.

When considering the role of the director, support the teacher. Jason spoke about our perspective and seeing things differently. He zeroed in on “perspective” and “perspective taking” which are two different things to consider. Everyone is aware of their own perspective, but do we have the ability to open ourselves up to see beyond what we believe to experience what others may be feeling and understand it? To conclude, Jason spoke about supporting the children. He highlighted positive approaches, function of the behavior, the meaning behind the behavior, supports, and resources. The tremendous amount of time and knowledge put into this presentation was greatly appreciated by all participants. They walked away with several strategies, resources, and questions to ponder. This presentation proved to be enlightening not just for our work in child care but who we are as people.

DCF Announces Project Growth Grant Recipients

Over \$20 million awarded to local communities and businesses across Wisconsin

MADISON – The Wisconsin Department of Children and Families (DCF) announced May 31, 2022 the award of over \$20 million in Project Growth grants to 28 cross-sector community teams and over 100 businesses to help solve the challenges facing Wisconsin’s child care system and bolster the state’s economy.

“We have seen in various communities across the state that when business, economic development, early learning, and other community partners come together and innovate, we all benefit,” said DCF Secretary Emilie Amundson. “These grants are helping us kickstart and build those partnerships, as well as find innovative and sustainable child care solutions that can be modeled in communities and businesses across the state.”

During the five-week application period the Project Growth grant program received a large amount of interest with over 660 Partner Up! applications and 39 Dream Up! applications. While funding was limited, DCF was able to award grants to communities and businesses in each region of the state, with an emphasis on areas deemed child care deserts.

Early Childhood: Child Find

Childcaring - A Community Partner in the Informed Referral Network

Child Find is a continuous process of public awareness activities, screening and evaluation designed to locate, identify, and refer as early as possible all young children with disabilities and their families who are in need of an Early Intervention Program (Part C) or Early Childhood Special Education (Part B) services of the Individuals with Disabilities Education Act (IDEA). School districts are required to locate, identify and evaluate children with disabilities within their attendance area. To assist in this child find process, districts have developed "Informed Referral Networks." An Informed Referral Network is comprised of community partners, including Childcaring, that work together to serve young children and their families. Relationships with community partners have proven to be the most effective practice in identifying children with disabilities. These partnerships provide an opportunity to learn more about screening young children and providing information about community resources. This community network refers children who may have a disability and a need for special education. DCF: June 2 Child Care Provider Update

Summer Heat Safety - Tips to Ensure that Summertime Fun Remains Safe

Summer welcomes warm weather and sunshine after months of snow and frigid temperatures, along with the opportunity for outdoor play! DCF has compiled some reminders to ensure summertime safety.

Inclement Weather: Licensing and certification rules require children have time to play outdoors unless there is inclement weather. Inclement weather during the summer is defined as heavy rain or temperatures above 90° Fahrenheit. Now may be a good time to review and update sunscreen and insect repellent authorizations.

Playground Safety: A child's body temperature rises 3 to 5 times faster than an adult's, making them more vulnerable to heatstroke. Be sure that children have ample access to drinking water, as well as shaded areas to rest beneath. It may be beneficial to review symptoms of heat-related illnesses with staff.

Transportation Safety: According to the National Safety Council, an average of 38 children die per year in hot cars as of October 2020, and 53% of incidents involve a parent or a caregiver forgetting the child was in the vehicle. Wisconsin administrative rules for all regulated programs prohibit a child from being left unattended in a vehicle. Always remember to look before you lock!
