Extra, extra... read all about it! Everyone seems to be talking about child care.

Did you have a chance to see the Daycare Dilemma series on WSAW-NewsChannel 7, by Emily Davies? If not, we have the links to each segment saved on our Childcaring website under News & Links. The series began by sharing those working in the child care field can often feel underappreciated for a variety of reasons, including what providers say is a lack of understanding from some parents and society at large about the work they do.

Until we're able to recognize how important child care is in the early years as a community as a society, I think we're going to continue to struggle, Kelly Borchardt said.

The series shared Childcaring data: in our 10-county service area we have lost roughly 3,000 child care spots due to providers closing their businesses (and that does not account for staffing shortages at centers). That makes it challenging for families to find care for their children. While there is no simple solution for this issue, Childcaring offers an opportunity to see if someone would like to build their own business within the early childhood education field with Informational Sessions and Start Up Grants.

The Daycare Dilemma series went on to share information about parents struggling to maintain adequate child care and how quality child care is foundational for a child's future.

Children are not just playing, but being able to articulate how children learn through play and how our environments and the things that we do are very intentional," Gayle Schiszik, Childcaring's provider certifier and pre-licensing technical consultant explained. "We put two telephones in a dramatic play area, not because in the dramatic play area, it's a home and there's a phone in a home right? But we put two because we want children to learn communication and the give and take. So, when we put two phones there, children start to have conversations with each other.

Emily Davies, NewsChannel 7 was there when the secretary of the Wisconsin Department of Children and Families, Emilie Amundson, said child care needs to be seen as a community issue, and it [DCF] committed funding toward that in several communities around the state, with several in the north central region.

As part of the Project Growth initiative through DCF, the Dream Up! Child Care Supply-Building grant program, administered by First Children's Finance, focuses on building child care supply through a collaborative community approach. Within Rounds 1 and 2, twenty-eight cross-sector teams in Wisconsin will receive strategic planning support (continued on page 3)

YOUNGSTAR TRANSITION COMING SOON

In November 2021, DCF issued a Request for Proposal for the administration of the YoungStar Quality Rating and Improvement System, as part of the normal contracting cycle. Following extensive evaluation of proposals, DCF will contract with a new administrator, Shine Early Learning. We are currently finalizing the contract. Shine will administer all YoungStar services after completion of a transition period with the current YoungStar administrator, Supporting Families Together Association (SFTA).

Shine Early Learning, SFTA, and DCF are all committed to working together on a smooth transition, with uninterrupted, high-quality YoungStar services. Although transition details are being finalized, it is important for us to communicate the following:

• Onsite consultation visits will continue to be an option within YoungStar for any program that requests it. DCF is committed to ensuring that all programs have access to onsite support now, and in the future.

• SFTA and the Child Care Resource and Referral agencies [i.e. Childcaring] will continue providing:

- Resources and referrals for families and providers
- Trainings and technical assistance
- Support for tribal nations
- Pre-licensing activities
- Project Growth activities

Shine Early Learning will be recruiting staff from within Wisconsin to ensure that regional and community knowledge continues within the program.

Once a transition timeline is in place, more detailed information will be shared through DCF's child care listserv, the YoungStar webpages, and stakeholder group meetings.

and \$75,000 in grant funding to evaluate, plan, sustain, and expand existing child care, and support new child care programs. Additional \$5,000 stipends will be allocated to participating child care providers who submit business improvement plans during the strategic planning process. Childcaring staff are participating on each of the Dream Up! teams in our service area: Adams, Lincoln, Marathon, and Taylor Counties. Other communities may be excited to apply for the next round of Dream Up! applications in early 2023.

The Daycare Dilemma series on WSAW-NewsChannel 7 ended in August, reminding us, "It takes a Village". This segment shared one local partnership that is working and challenged us to think more about how each of our communities can meet the needs of working parents and their children, employers, and child care providers. The advice included: meet with community partners, research government resources, do not be afraid to adapt and make changes, and most of all, ask for help.

We can see the impact of the additional federal child care funds on the child care market from the past federal COVID-19 relief measures. Those investments are working!

The industry did not collapse. But the stabilization strategies are temporary. We need to figure out long-term ways to invest in child care as a public good so parents can work, children can learn and those who work in child care can earn sufficient wages to support their own families. This is the time to advocate for long-term investments for early childhood! We encourage you all to get involved in community conversations. Exciting Child and Adult Care Food Program (CACFP) Reimbursement Updates!

The Child and Adult Care Food Program (CACFP) is a federally funded program sponsored by the United States Department of Agriculture (USDA). As a licensed or certified child care provider, the program provides you with financial reimbursement for serving nutritious meals and snacks to kids in your care.

Reimbursement rates are adjusted annually. This year there was an extra \$0.10 per meal & snack provided by the Keep Kids Fed Act that is included in the published rates.

USDA REIMBURSEMENT RATES

Rates are adjusted annually each July, as required by the statutes and regulations governing CACFP. Here are the annual adjustments effective July 1, 2022 through June 30, 2023:

Rates per meals served in adult day care centers and child care centers

The number of meals served to enrolled participants multiplied by the rates of reimbursement for each meal type. Below are the current reimbursement rates:

	Breakfast	Lunch/Supper	Snack
Non-Needy (N)	\$0.45	\$0.47	\$0.19
Reduced (R)	\$1.91	\$3.63	\$0.64
Free (F)	\$2.21	\$4.03	\$1.18

Family Day Care Homes (FDCH) Meal Reimbursement Base Payment Rates

Keep Kids Fed Act 2022 authorized a Tier 2 FDCH to be considered a Tier 1 FDCH for the purposes of the program. This will provide



Tier 2 homes with Tier 1 meal reimbursement rates only for the time period beginning July 1, 2022 and ending on June 30, 2023.

Tier 1 and Tier 2 reimbursement rates per meal type:

Meal Type	Tier 1	Tier 2
Breakfast	\$1.66	\$1.66
Lunch/Supper	\$3.04	\$3.04
Snack	\$0.97	\$0.97

Provider's Own Children

Providers may receive meal reimbursement (at Tier 1 rates) for meals served to their own enrolled children, foster children, and/or other residential children only if they are eligible based on their own household size and income (or participation in qualifying Benefits Programs).

October is Sudden Infant Death Syndrome (SIDS) Awareness Month.

In October and beyond, infant caregivers and service/healthcare providers can join Safe to Sleep[®] and its partners to encourage safe infant sleep and help raise awareness about ways to reduce the risk of SIDS.

Despite decreases in rates of SIDS and other sleep-related infant deaths, more than one-third of sudden unexpected infant deaths that occur in the United States each year are from SIDS.1 Research also shows that unsafe sleep areas, such as those that include non-fitted sheets, blankets, or stuffed toys, remain a leading cause of infant death.

Good Start Grants Expanding!

After many years of Scholarship Aid being available for families in Wood County and portions of Clark County, Childcaring will be transitioning that into our current program, Good Start Grants! Good Start Grants (GSG) helps eligible families pay for quality child care. GSG are intended for families under 300% of the federal poverty level, but are not receiving state child care assistance (WI Shares) to pay for child care. GSG pays a portion (up to 65%) of a child's weekly tuition directly to their child care provider.

GSG is currently available in Marathon and Portage Counties, and the Marshfield Area United Way service area. Starting in 2023, GSG will also be available in South Wood County thanks to support from the United Way of South Wood & Adams Counties.

Child Care Counts: Stabilization Payment Program Round 2

The Department of Children and Families (DCF) has allocated \$351 million in funds for the Child Care Counts: Stabilization Payment Program to support Wisconsin's early care and education community. The Stabilization Payment Program Round 2 is a ninemonth payment program that runs August 2022 through April 2023. It will be followed by an additional nine-month payment program, with the renewal application opening in May 2023. Once approved for payments, eligible providers may continue to receive ongoing monthly payments, providing the financial stability they need to stay open, to recruit and retain qualified staff, and to continue providing high-quality care for children.

These funds will be distributed through two programs targeting the challenges early care and education providers are facing. Details about each program can be found at: https://dcf.wisconsin.gov/covid-19/childcare/payments.
