Childcaring Secures ARPA Funding to Strengthen Early Childhood Support

Childcaring is proud to announce its recent partnerships and funding initiatives supported by the American Rescue Plan Act (ARPA). Signed into law in 2021, ARPA provides crucial funding to address the health and wellness needs of communities impacted by the pandemic.

In collaboration with **Clark** and **Langlade** County health departments, Childcaring has introduced Calming Areas in child care settings. These dedicated spaces within group center classrooms and family child care homes help children manage their emotions, offering tools and techniques to self-regulate without leaving the environment. This innovative approach equips children with lifelong emotional management skills.

"Child care centers are valuable assets in our communities," said Brittany Mews, Clark County Health Officer/Director. "When the Clark County Health Dept. had an opportunity to support local child care centers, we eagerly pursued this collaboration to ensure the well-being of our youngest learners."

Childcaring is also partnering with Marathon and Wood Counties to address critical child care shortages.

- Marathon County: With \$200,000 in funding over two years, Childcaring will provide free foundational training for up to 15 new child care professionals annually, alongside \$5,000 employer stipends. These efforts aim to create additional child care slots, helping families maintain employment and boosting the local economy.
- **Wood County:** The board has approved a \$402,000 allocation to Wood County Health Department (WCHD) to support child care initiatives. WCHD will subcontract with Childcaring to provide one-time startup and expansion grants to rebuild child care capacity. Funding includes up to \$100,000 for new or expanding group centers, \$10,000 for new family providers, and \$5,000 for certified providers seeking licensure. Additional funding will support a shared services network to enhance efficiency and collaboration among child care providers.

Over the next two years, Childcaring will work closely with community leaders to implement these initiatives, fostering growth and resilience within the child care sector.

These investments not only support child care providers but also strengthen the foundation for thriving families and a robust local economy. We sincerely applaud and admire the efforts of the many individuals who serve on the local child care coalitions in these communities!




Understand the Weather

New training format!

Supporting Families Together Association (SFTA) and Child Care Resource & Referral (CCRR) Partners have created a new training format to help meet training needs! Self-Paced, E-Learning is a new on-demand format through ECExplorer. Participants will work at their own pace to complete courses within the set timeframe. Are you familiar with the QUEST Grant?

Through the Department of Labor, the QUEST grant was issued with the intent of creating more child care slots and helping struggling centers to remain operational. The main goals are:

- **Certified and Licensed Family Care** New Start Ups, Retention, or Transition to Licensed (Up to \$5000 in supportive services such as safety supplies, indoor and outdoor play equipment, highchairs, cribs, fingerprint and pet fees, radon remediation, fencing)
- **Staff Training**-including child care foundational courses, continuing education hours, certificates, technical diplomas, associate degrees, director's admin certificate- individual staff must apply (tuition and support including books, supplies, mileage reimbursement to class)
- **Disaster Relief Employment (DRE)** 100% wage and fringe reimbursement for new hire (any position) until 9/30/2025 or funding is exhausted (need to refer to QUEST before job offer and preferably 2 weeks before intended start date). This opportunity is available when center is struggling to remain operational due to lack of staff or budget crisis.

As it is federal funding, there is an application and eligibility requirements. To start the process, scan the QR code and a Career Planner will reach out. If you have questions, contact: Amy Hoppa, QUEST Grant Coordinator at ahoppa@ncwwdb.org or 715.343.4330.

This course includes Abusive Head Trauma (AHT) Prevention Training, Sudden Infant Death Syndrome (SIDS) Risk Reduction Training, and Mandated Child Abuse and Neglect Reporter Training. Each of these trainings meets the requirements for child care providers to work in a regulated program.
